Procedures for Applying for a Criminal Record Certificate for Overseas Travel

1. Those who can apply at the Kumamoto Prefectural Police

Those who have been requested by an overseas public institution (Embassies, immigration offices, etc.) to submit a criminal record certificate (Hereinafter referred to as "Certificate".) and who fall under any of the following categories:

- (1) In principle, those who are registered as residents in Kumamoto Prefecture
- (2) Those who live overseas and whose last resident registration in Japan was, in principle, in Kumamoto Prefecture

2. Notes on Application

- · Fingerprints will be taken when applying, so be sure to come in person.
- If your passport is about to expire, apply after you have renewed it (your passport number will be printed on the certificate).
- If you live overseas, you can also apply at the Japanese Embassy in your country.
- If you have already applied for a certificate at an overseas Japanese Embassy or other prefectural police, you cannot apply twice for the same reason.
- It takes about one week to issue a certificate (It will take more days during the year-end and New Year holidays.).
- Depending on the reason for your application, we may not accept your application immediately, so please contact us in advance.
- The certificate will be written in five languages (Japanese, English, French, German, Spanish) and delivered sealed.
- The certificate cannot be mailed. You or a representative who has been requested to receive it must come directly to the application location 3 below to receive it.
- Opening is strictly prohibited. If it is opened, it will lose its validity as a certificate, so please submit it to the requested institution without opening the seal.
- · There is no fee.
